

Memorandum of Understanding (MoU)

between

Tripura University (A Central University) and Techno India University, Tripura for

Promotion of Inter-institutional Research collaboration, Faculty & Student Exchange program, Exposure visits, Staff and Students' Training, sharing of laboratory facilities and Postgraduate Research

WHEREAS the "First Party" envisages that the objective of the University shall not only be "to disseminate and advance knowledge by providing instructional and research facilities" in the state in areas of contemporary relevance to the society and the country (with the motto "pursuit of excellence") but to make special provisions for studies in tribal life and culture and to introduce vocational subjects with a view to provide employment opportunities to the students.

AND WHEREAS the "Second Party", The Techno India University, Tripura (TIUT) is an initiative of Techno India Group (TIG) and was established in Tripura under The Tripura Act No. 04 of 2023 vide letter No. F.2(407)- DHE/UDCA/2022(L)/1329(07), dated 15/05/2023 and subsequent approval was received from the University Grants Commission (UGC), Ministry of Education, Govt. of India, New Delhi under Section 2(f) of UGC Act 1956 vide letter No. F.8-27/2023(CPP-I/PU), dated 3rd January 2024 and enlisted on the UGC website as S1. No. 429. Further, TIUT is also registered in the AISHE portal vide Code No. U-1302 and the National Scholarship portal (NSP). TIUT is a multidisciplinary State (Private) university and



currently offers programs in various fields including Computer Science and Technology, Humanities, Management, Natural Sciences, Agriculture, Commerce, Law, and Fisheries Sciences, and our curriculum is aligned with the National Education Policy (NEP) 2020. The University's foremost objective is the advancement of knowledge and skills through contemporary teaching methodologies and leading-edge technology, with a strong emphasis on meeting industry demands and fostering entrepreneurship.

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in the projects requiring expertise and logistics from both the parties.

Both the parties have decided to enter into this MoU and agree hereby as per articles given below:

A. Background & Purpose

The parties believe that it is in their best interests to encourage direct contact and cooperation between their faculty members, departments, institutes and other research centres in order to foster the development of possible collaborative projects and activities in fields of teaching and research to be agreed upon, subject to the availability of funding and the development of the specific binding agreements. The parties have entered into this MOU for the purpose of setting forth their mutual understanding and agreement with respect to such direct contact and the development of potential of cooperative programs.

B. Discussion and Development of possible Collaboration

Within the fields of teaching and research to be mutually designated, both parties agree to discuss and explore the development of any of the following general forms of cooperation.

- 1. Exchange of Faculty;
- 2. Exchange of Graduate/Post Graduate students;
- 3. Collaborative research projects;
- 4. Lectures and sharing of experience to develop better teaching methods;
- 5. Other cooperative activities in the fields of mutual interest:
- 6. Sharing of Laboratory and Library facilities on mutual interest;
- 7. Exposure Visits.
- 8. Training of Staff and Students
- 9. Post Graduate Research in the field of expertise available at participate institutes.
- C. The parties anticipate that specific collaborative projects or activities that the parties wish to implement will, as appropriate, be undertaken pursuant to future agreements entered into in accordance with applicable law and the rules of each party.

E. Continuation of All Current Policies

During the course of the discussion contemplated by this MoU, the parties will continue to operate their respective academic programs in accordance with their established policies, rules and procedures.

F. Term of MoU

This MoU shall be effective from the date of signature and shall continue in effect for a period of five (5) years thereafter unless terminated as provided for herein.

Either party can terminate this MoU for any reason upon six (6) months prior written notice to the other party. At the end of its effective period, this MoU may be renewed upon written mutual agreement of the parties.

G. Nonbinding Terms

This MoU shall not be constructed as creating any legally binding rights or obligation on the part of either party and shall not be enforceable in law or equity in any court or tribunal for any purpose. In case any dispute arises, the heads of each institute will settle the dispute amicably and it is made clear no sue or case is not sustainable in law in respect of any dispute arises between the parties. No clause can be included or excluded during the period of MoU without mutual consent of the parties.

This MoU does not create any financial liability on either of the parties.

This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party).
